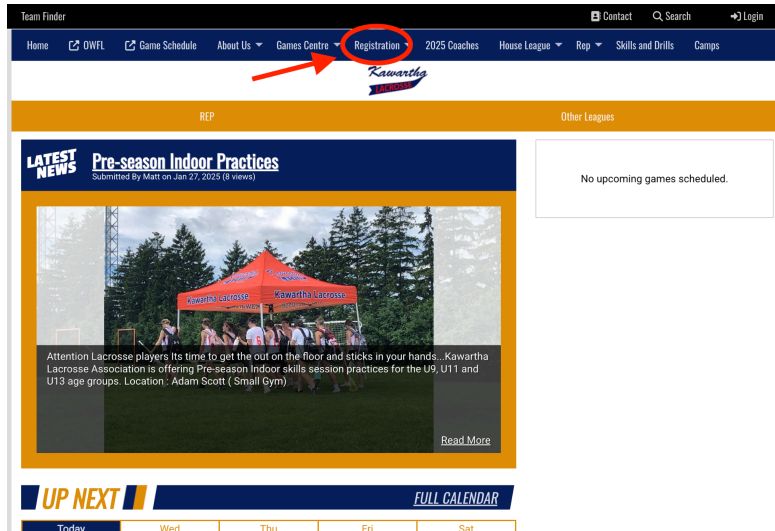
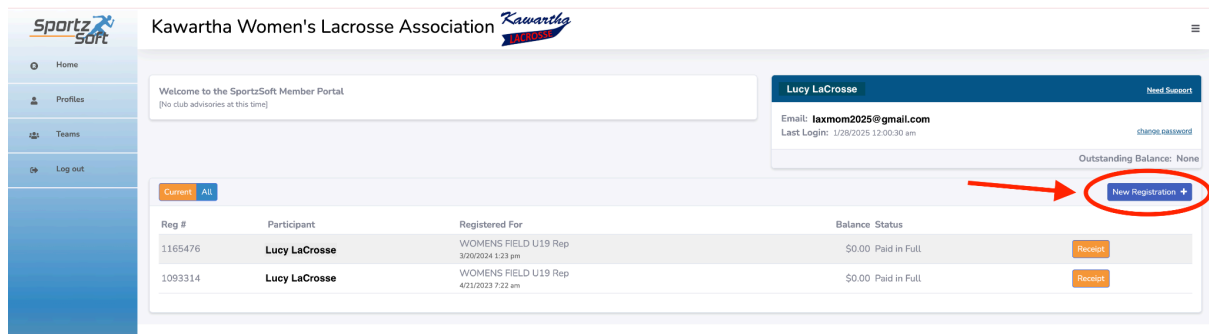


# How To Register for Kawartha Lacrosse

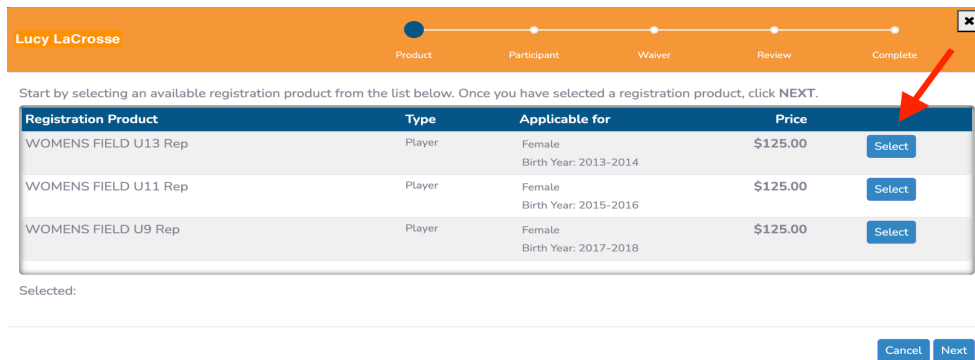
All new and returning players will go to our new Kawartha Women's Field Lacrosse website <https://kawarthalacrosse.previewsh.ca/> and click on the 'Registration' tab.



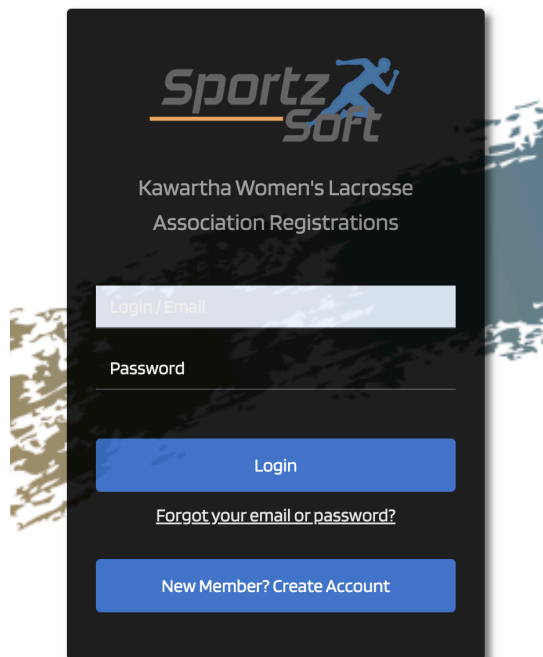
**RETURNING PLAYERS:** If your child has previously played in our Kawartha houseleague program and/or on one of our rep teams, log into your Sportzsoft account using your existing login and password. DO NOT create a new login/account. Select your player profile and click on 'New Registration'.



Click 'Select' for the appropriate team, click 'Next', and then proceed with payment.




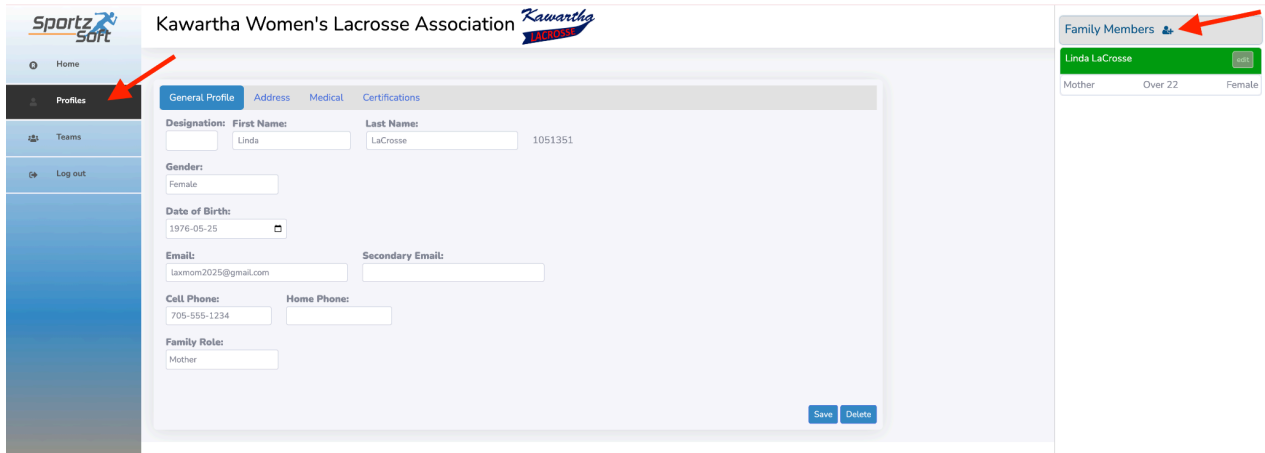

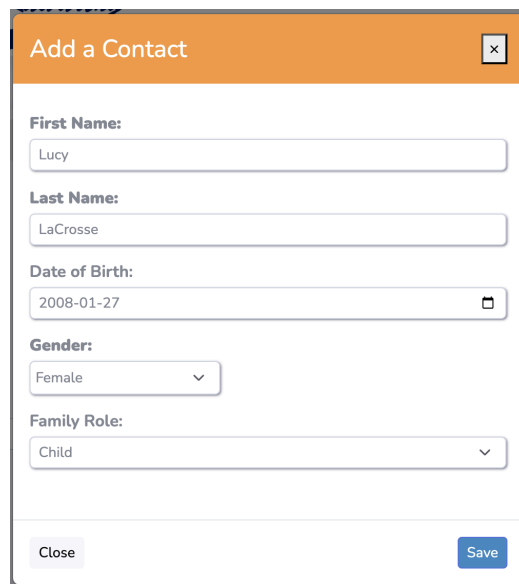
Once you have created an account, you will be asked to enter some personal details. This is YOUR information, not the personal information for your child(ren). (Note: Be sure that you enter your child's home address in this section). Once you are finished, click 'Create Account'.

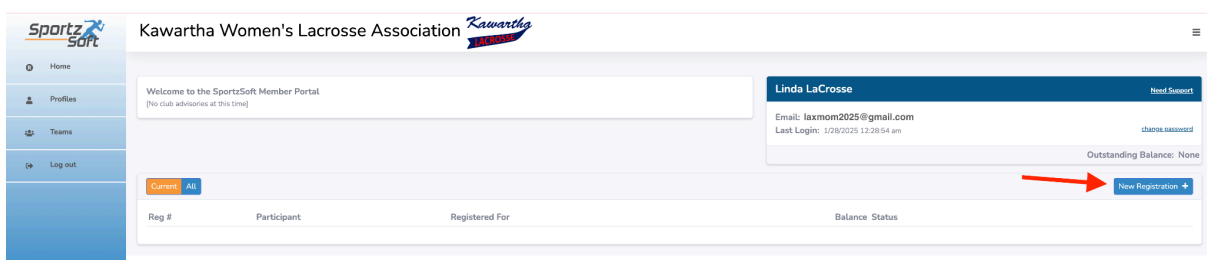

**RELEASE OF LIABILITY, WAIVER OF CLAIMS AND INDEMNITY AGREEMENT & MEMBERSHIP CONSENT FOR UNDER 18 YEARS**

**APPLICATION.** This waiver applies to all participants under the Age of Majority in the Province of Ontario, or the province or territory where lacrosse programs are provided by the Association. This waiver applies to the named participant (the "Minor") for which this registration is completed. The named parent/guardian of the Minor being registered confirms full legal responsibility for the decisions of said Minor.

**COLLECTIVE.** The Ontario Lacrosse Association (the "Association") and its directors, officers, agents, representatives, employees, volunteers, members, participants, players, coaches, officials, spectators, Zones, Technical Support Groups, Associations, Leagues, Clubs, business operators, agents, site property owners, independent contractors, subcontractors, sponsors, successors, and assignees (collectively the "Releasees").

**DEFINITIONS.** In this Agreement, the term "Lacrosse Programs" shall include all contact and non-contact activities, programs, events, courses, meetings, and services provided, sponsored or organized by the Association and/or its members, including but not limited to: games, tournaments, practices, camps, technical clinics, championships, conditioning programs and/or training, use of strength training and fitness conditioning, equipment, machines and facilities, orientational or instructional sessions or lessons provided by or sanctioned by the Association or its Releasees.

**JURISDICTION.** This agreement and any rights, duties, obligations between the parties to this Agreement shall be governed by and interpreted solely in accordance with the laws of the Province of Ontario, and I agree to attend solely to the jurisdiction of the Courts of the Province of Ontario. Any litigation involving the parties to this Agreement shall be brought solely within the Province of Ontario and shall be the exclusive jurisdiction of the Courts of the Province of Ontario.

**Rowan's Law**

On July 1, 2019, new rules came into effect through Rowan's Law, to improve concussion safety in amateur competitive sport in Ontario. If you are an OLA athlete under 26 years of age, the parent of an athlete under 18, a coach, a team trainer or a game official, you need to follow the rules of Rowan's Law, outlined in the link below...
